IMPORTANT NOTICE FOR THE STUDENTS

For OBC Non-Creamy Layer candidates: It is clarified that as per DOPT office memorandum No. F.No. 36036/22013-Estt. (Res-1) dated 31st March 2016; the applicant is required to submit the valid non-creamy layer certificate covering three preceding financial years i.e. issued after March, 31, 2020 for this academic year.

For EWS candidates it is further stated that the EWS certificate must be as prescribed in Appendix V of BOI and must be issued after March 31st, 2020. These may be issued by Tehsildar/Naib Tehsildar/SDM.

In case any documents are found false at the time of physical verification of certificates, the admission is liable to be cancelled.

In the meantime, applicants are allowed to take admission by submitting the self-attested copy of acknowledgement slip and undertaking of ensuring the production of the certificate within the stipulated period mentioned in the undertaking.
