MINUTES OF THE GOVERNING BODY MEETING

A meeting of the Governing Body of Maitreyi College was held on Saturday, November 30, 2024 starting from 11:00 AM in the College Committee Room. The following members were present:

Item 2 : The minutes of the meeting of the Governing Body held on October 10, 2024 were confirmed with the following suggestions:

Item no. 14: The Governing Body advised that the books to be written-off should be displayed for all the students and the staff for a week's time. If someone wish to take any of these books, he/she may do so. The library should maintain a proper record of all such books and the details of the person whosoever takes the books.

Item no. 31: The Governing Body advised that the College should obtain estimates for porta cabins instead of semi pucca class rooms.

- : The Governing Body ratified the action of the Honorable Chairperson, Governing Body in re-appointing the Assistant Professors, who were working on ad hoc basis in the different departments of the College, as per the details attached with the minutes, with an advice from the Chair to conduct interviews on permanent position as soon as possible.
- Item 4 : The Governing Body ratified the action of the Honorable Chairperson, Governing Body, in granting commuted leave for a further period of 45 days from October 24, 2024 to December 7, 2024 to Dr. Gita Batra Narula, Associate Professor, Department of Chemistry.
- : The Governing Body noted that as per the University guidelines, the number of permanent teachers on Study Leave, EOL and Child Care Leave put together should at no time exceed 10% of the total number of sanctioned teaching posts in the College. At present, the College has 168 permanent faculty members on its roll and 10% of 168 comes to 16.8 = 17. Therefore, the Governing Body permitted the College to keep 8 seats for Study Leave/EOL and 09 seats for Child Care Leave.

Grant of sabbatical leave to Dr. Manju Bhardwaj, Associate Professor, Department of Computer Science: The Governing Body was of the view that Dr. Manju Bhardwaj should

provide the details regarding the post-doctoral research to be undertaken i.e. whether she would be joining her guide under some project. Has the necessary approval been taken from the University in this regard? She should submit the synopsis of the work she intends to undertake and its expected outcome. The same may be placed before the Governing Body in its next meeting.
